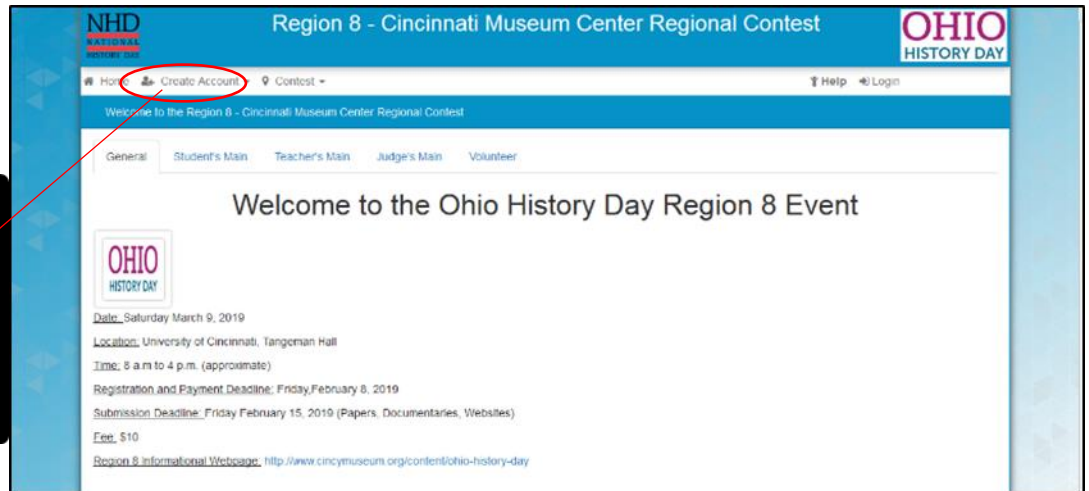
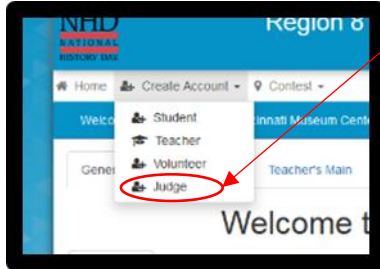


# OHD Judge Registration

1) Go to the registration page at <https://oh-rcmcr.nhd.org>.

2) Go to the "Create Account" tab in the upper left section of the page and choose "Judge" from the drop down menu.



3) Complete the information and click next.

The same email can be used for multiple judges but each must register under their own name.


